**SUPPLY AND ON-SITE DELIVERY OF UPVC PIPES WITH ASSOCIATED FITTINGS FOR THE REPLACEMENT OF EXISTING WATER RETICULATION IN VICTORIA WEST FOR A CONTRACT PERIOD ENDING 30 JUNE 2022**

Ubuntu local municipality invites:

Suppliers of water pipes and fittings, complying with the relevant SABS standards, to submit tenders for the supply and on-site delivery of UPVC pipes with associated fittings for the replacement of existing water reticulation in Victoria West.

Quantities per nominal size will be specified in the tender documentation.

Tender documents will be available on **23 July 2021** on the website of the **UBUNTU LOCAL MUNICIPALITY**.

Sealed tenders, marked: "**Contract No: UB/VW/07/2022: SUPPLY AND ON-SITE DELIVERY OF UPVC PIPES WITH ASSOCIATED FITTINGS FOR THE REPLACEMENT OF EXISTING WATER RETICULATION IN VICTORIA WEST**" must be placed in the tender box at Ubuntu local municipality, before 12h00 on 11 August 2021. Tenders will be opened in public immediately thereafter.

The following conditions will apply:

- Prices quoted must be inclusive of VAT.
- A firm delivery period must be indicated.
- Bids will be evaluated in accordance with Method 2: Financial offer and preference, qualifying tender offers will be evaluated according to the 80/20 point system, where the financial offer will account for 80 points and preferences for 20 points. **The evaluation will be done based on the price submitted based on the total of the bill of quantities that form part of this tender document.** All the returnable forms must be completed and submitted with the bid. **Bidders are required to, together with their bids, submit an original and valid B-BBEE Status Level Verification Certificate or certified copies thereof to substantiate their B-BBEE rating claims. Materials will be purchased as needed during the contract period.**
- Bids that are late or incomplete will not be considered, whilst the lowest or only bid will not necessarily be accepted. Bids per fax or e-mail will also not be considered.
- **Tenders shall be registered and in good standing with the South African Revenue Service (SARS) and shall submit documentary evidence in the form of a valid Tax Compliance Status (TCS) Result Letter for Tender, indicating the TCS PIN, issued by SARS.**
- Bids must be accompanied with documentation to verify competency.
- The 80/20 preferential points system will be applied to evaluate this tender. **No B-BBEE points would be allocated if a certified copy of the B-BBEE certificate or an original Sworn Affidavit is not attached to the bid document.**
